"We've earned our feathers here," said Hammond. "It's been three and a half long years. I've lost a lot of time — I think everyone has."

"Through this election, we have come together, put aside our differences, and are starting the process of healing," said Reid. "The participation of the tribe in this election showed overwhelmingly who our members want to lead them."

"It was a landslide election," said Walker.

Only about half of those eligible to vote Oct. 3 did so, according to Marc Benjamin of the Fresno Bee, and a fourth of the candidates withdrew their names from it beforehand.

Candidates Reggie Lewis, Nancy Ayala,

Melvin Espe and Donna Featherstone questioned in appeals whether those who voted were eligible, because a 2010 voter roster was used for the election. By 2012, about 150 of those members had been disenrolled, a common practice that has increasingly divided the

Since it was officially recognized in the 1980s, the tribe's membership has dropped by half — from 1.800 to about 900 — according to National Public Radio. Most were disenrolled since the casino opened in 2003. Each month, official tribal members received a portion of casino profits. When membership shrinks, monthly checks grow for those who are left.

"We don't have that much to share," faction leader Lewis told NPR in 2013. "We've got tribal members who are living

in gutted-out trailers with no sanitary facilities, without power. And then we have people who are trying to take advantage of being a tribal member when they're not entitled to be in."

For now, those checks have stopped. An armed raid of the casino by a rival faction resulted in its shutdown by federal authorities on Oct. 10, 2014.

Before this month's election, Utah attorney Anthony Famulary who serves as a tribal court judge — issued a temporary restraining order to stop any election until enrollment issues were resolved. The order was sought by a "distributee" faction led by Luke Davis, but was not accepted by the Reid faction.

Monica Lewis of the "on-reservation tribal council" has said it does not accept the voter list of this month's election and will hold an election of its own in December. Her faction occupies some tribal government buildings across from the casino, including the enrollment office.

October's election was to decide who will replace the tribe's 2010 council members, who were essentially reinstated as an interim council in a 2014 ruling by the Bureau of Indian Affairs and the Interior Board of Indian Appeals.

The 2010 tribal council was the last one to be uncontested.

Reid promised at his installation that reopening the casino would be the new board's top priority.

"Please be patient," he said. "It took four years to put us here but we are working hard already to get us moving forward again."

One had the good fortune of making it to Spain and then home without being captured. As for Emmert and his nose gunner, who was also wounded, they remained with the plane and were cap-

After being paraded through the streets of Urk, Wallace was taken to Queen Wilhelmina Hospital in Amsterdam. There fate smiled on the young Maderan when he was placed under the watchful eye of a protective German surgeon. Not only did the doctor operate on Emmert, he made sure the German soldiers did him no harm.

Two of the nurses were just as kind, but that goodwill came at a high cost. They looked after their patient and brought him extra food, which they hid under his bed.

Unfortunately, the German soldiers caught one of the nurses in one of her acts of mercy and executed her by decapitation.

The other one survived the war and later made a

On Dec. 31, 1943, Wallace was put on a train and taken to another hospital in Obermassfeld, Germany, for additional medical treatment. While he was there, the German who was in charge of the compound committed suicide.

In September 1944, Emmert learned that he was going to be expatriated in a prisoner of war exchange. He was taken through Germany, where he saw first-hand some of the destruction the U.S. military had wreaked on the Nazis. He wound up in Sweden, where he boarded a POW exchange ship, the Gripsholm Sverige.

Wallace docked in New York and boarded a train for California. He traveled across the country to Palm Springs. From there he hitchhiked back home to Madera, where his family welcomed him with a huge party.

On Christmas Day, 1944, Wallace married his high school sweetheart, Eleanor, after which they traveled to an Army base in Washington for further treatment. Meanwhile, he prepared to return to farming with his father.

While he was in Wash-

ington, he wrote a letter home with a special request. He told his father that he would like to build a 1,000-foot runway on the farm. Apparently Wallace wasn't finished with flying yet.

Wallace Emmert spent the next 30 years farming. Eleanor passed away in 1982, and a few years later he married her sister, Maxine. They have been married for 31 years.

Today, Wallace and

Maxine Emmert can be seen sitting together holding a treasure from World War II. In their laps is a scrap book emblazoned with an eagle looking down on a B-17 in flight, and inside are the letters Wallace sent home from the war and kept by his mother — letters of a young hero from Madera who never imagined he would look back on his life from the perspective of 100 years.
